

### Steering (SC)

To collect and analyze results and the progress of dldp's work (both its contributions and the **changes** they effect) and to steer the further development and make adaptations if necessary.

### **Learning: (National Platforms and** regional CC)

To capture or 'capitalise' experiences for **learning** – at many levels including within the dldp team, within partner LGUs, within service provides, among national stakeholders and the international development community.

Providing evidence for policy is an important objective of this learning.
